Kern County District Attorney's Victim Witness Unit, Elder Abuse Unit, and the Kern County Family Justice Center Announce New Location in Downtown Bakersfield

(Bakersfield) – The Kern County District Attorney's Office is happy to announce that all victim services in Bakersfield will now be under one roof beginning September 18, 2023. The Kern County Family Justice Center, the Victim Witness Unit, and the Elder Abuse Unit will now be located at 1300 18th Street in Downtown Bakersfield.

Kern County Family Justice Center

Previously located on Oak Street, the new building is conveniently located just down the street from our District Attorney's Office and the Kern County Superior Courthouse. Our centers are a unique and safe place where victims of domestic violence (DV), human trafficking (HT) and sexual assault (SA) can receive free services and resources to help break the cycle of violence. In collaboration with community partners, our centers offer victims and their families the following services:

Victims Witness and Elder Abuse Units

Previously located on the 7th floor of 1415 Truxtun Ave., the Kern County District Attorney's Victim Witness and Elder Abuse Units are dedicated to ensuring the rights of crime victims are enforced and that victims have a meaningful voice throughout the criminal justice process. Victim Advocates assist with:

- Advocacy and Court accompaniment
- Providing an in-depth orientation of the Criminal Process
- Providing ongoing status of a Criminal Matter
- Providing Court Support
